Co-Chair Betsy Craft called the meeting to order at 4:35 p.m.

Approval of Minutes:

A motion was made to approve the May 2024 work group meeting minutes. Motion approved.

SAMSHA Recovery Meeting Recap (Betsy Craft):

Betsy provided a recap of the meeting, which included a presentation about advancing the peer support workforce in carceral settings. She also spoke about attending a SAMSHA national summit related to harm reduction best practices, which included harm reductionists and persons with lived experience.

BHA Recovery Services Update (Alia Andrews):

A new vendor (Solari) will be managing the Colorado crisis line (988). The BHA team is working closely with Solari and Rocky Mountain Crisis Partners to ensure a smooth, collaborative, transition. The peer support line will be expanded. https://crisis.solari-inc.org/

Jen mentioned that some of the current RM Crisis Partners peer professionals had expressed concern related to the transition, and that it now appears that Solari might be hiring some of the RM Crisis Partners peer professionals.

Peer Support Professionals Association Update:

COPA – CPFS Committee Members:

Committee member Alia Andrews provided information on the committee's work and said participating in the committee presents a unique opportunity to learn more about certification, grievances, and other committee responsibilities.

Jen Place asked if COPA is considering different "levels" for the CPFS credential. Precious Collins indicated this is being considered and other states' credentialing levels were being reviewed. Currently, the only credential offered is the Colorado Certified Peer and Families Certification. Oregon, for example, offers a Peer Mentor Certification, which is equivalent to the Colorado certification. Precious also mentioned the need for supervision training.

Alison said that Arkansas has a supervision credential separate from the peer credential.

Precious added a link to International Certification & Reciprocity Consortium (ICRC): https://internationalcredentialing.org/member-boards/ She indicated that the State of Arkansas did not appear in the listing; however, they might offer peer certification under a different credentialing body such as NAADAC https://www.naadac.org/

<u>Subcommittee - Advancing the Peer Support Workforce in Carceral Facilities (Betsy Craft):</u>

The subcommittee was established in February of 2024. Subcommittee members Jacob Merrion, Jesse Henderson, Bob Schultz, and Betsy Craft gave a presentation at the recent Faces & Voices of Recovery *Recovery Leadership Conference*. A recent committee survey is now being analyzed. The research team is currently conducting a landscape analysis of MOUD, harm reduction, and peer support policies within jails. Garfield County Jail is one unique jail with a peer support policy in place thus far.

The subcommittee is reviewing other states' policies and plans to make policy recommendations to the Colorado Jail Association and the County Sheriffs of Colorado. In the fall, another presentation is planned for the Attorney General's office. Work group members interested in joining the subcommittee were asked to contact Betsy: betsy.craft@csuglobal.edu

<u>Subcommittee – Medicaid Billing & Best Practices (Rourke Weaver):</u>

Due to competing commitments, the committee did not meet regularly until the current week. The subcommittee is working on a PowerPoint presentation for mental health professionals.

The committee reviewed Medicaid billing and third-party billing practices and determined there is a lack of billing standardization. This subcommittee is open to new members.
