Co-Chair Josh Blum called the meeting to order at 12:03 p.m.

Approval of Minutes:

A motion was made to approve the May 2021 work group meeting minutes. Motion approved.

Updates:

Ali Rosenberg reported that the Colorado Hospital Association is helping hospitals with opioid disorder related measures for the HCPF Hospital Transformation Program (HTP). For hospitals or organizations working on supporting the program, email Ali.Rosenberg@cha.com for additional information.

Liz Grace provided updates on CPEP's current course curriculum, including a prescribing controlled drugs course. They have new faculty.

Meredith Davis said a significant amount of funding has been allocated by legislation in addition to block grant funding. Grant funding will be earmarked for recovery support services.

Sarah Jean Cardona is working on a digital story telling project related to overdoses and naloxone use. Participants are expected to commit to 24 hours of training and will receive a \$250 gift card for their time. <https://clas.ucdenver.edu/anthropology/digital-storytelling-project>

Gina Olberding mentioned that Steve Koestler, a retired CU Anschutz Anthropology Professor, is also working on digital story project funded by the State Department of Health. The stories will feature individuals who have saved lives using naloxone.

Gina reported on a partnership with the CDPHE Prevention Unit, which developed a program focusing on effective pain management for dentists and oral health care providers. The program consists of 15 minute provider-to-provider educational videos that can be viewed in the provider's office. Dr. Don Teater is the presenting provider. The dental licensee can use the educational video to satisfy license renewal requirements. A question was raised regarding the possibility of expanding this educational opportunity to other states.

J.K. Costello will be addressing the Treatment Work Group on July 22nd regarding Contingency Management, legislation, and funding priorities for CM expansion. Jamie Feld said there was a 30% increase in overdose deaths in 2020 over the previous year. <https://www.cdc.gov/nchs/nvss/vsrr/drug-overdose-data.htm> A number of events are being planned statewide for Overdose Awareness Day in August.

Legislative Updates:

HB 1276 contains changes for providers. DORA is currently working on a summary of the new prescription requirements. Jose mentioned the potential coordination between the Provider Education Work Group and the Benzodiazepine Action Work Group regarding benzodiazepines and provider education related seminars.

The American Rescue Plan funding allocates \$1 million in funding to the Consortium for provider education, the grant writing program, and recovery support services. This funding is in addition to money available from CoBank. Funding will support future work group projects and some of the School of Medicine programs. Future projects will also consider provider needs.
