Advancing the Peer Support Workforce in Carceral Facilities. Committee members have several speaking engagements planned, including a presentation to the County Sheriffs of Colorado. Presentations will address the barriers experienced by peer support professionals who work in carceral facilities.

<u>Medicaid Billing & Best Practices</u>. Committee members met recently for a full-day workshop focused on parity for peer services billing.
